## 1. General call description

The Francesco della Valle Foundation purpose is to pursue the promotion of scientific research in the medical and biology field, with particular reference to neuroinflammation, both at a central and peripheral level. To this aim, the Foundation is issuing the "**Excellence in Neuroinflammation Award**" to recognize the remarkable and outstanding scientific publications by Young Researchers (under the age of 40) in the field of the natural mechanisms of neuroinflammation. Within the aforementioned aim, studies focused on non-neuronal cells (e.g., microglia, mast cells) will be preferred. The award is designed as a form of support and encouragement for researchers at the early stage of their career. The name of the awardee will be formally announced at the "Francesco della Valle Foundation" website and the 2025 Excellence in Neuroinflammation meeting.

## 2. Excellence in Neuroinflammation 2025 Award call

An award of EUR 3,000.00 will be granted to the best original research article published or accepted for publication between January 1<sup>st</sup>, 2024, and December 31<sup>st</sup>, 2024. The awardee will be notified by the end of March and will be invited to present his/her work at the 2025 Excellence in Neuroinflammation Meeting to be held next fall in Italy.

## 3. Eligibility

The application must fulfil the following criteria:

- 3.1 Author: Young Researcher (under the age of 40 at the time of submitting the application) of any nationality.
- 3.2 Publication: Original research article published, or accepted for publication, in international peer reviewed and PubMed indexed Journals, between January 1<sup>st</sup>, 2024 and December 31<sup>st</sup>, 2024. A review article will be considered in exceptional cases, only when it represents an extraordinary contribution, in a high impact journal.

## 4. Exclusion criteria

### 4.1. Applicants shall be excluded from the grant award procedure where they:

- a. have been sentenced by final judgment on one or more of the following charges: participation in a criminal organisation, corruption, fraud, money laundering, terrorist financing, terrorist offences or offences linked to terrorist activities, child labour or trafficking in human beings;
- b. are in a situation of bankruptcy, liquidation, termination of activity, insolvency or arrangement with creditors or any like situation arising from a procedure of the same kind, or are subject to a procedure of the same kind;
- c. have received a judgment with res judicata force, finding an offence that affects their professional integrity or constitutes a serious professional misconduct;
- d. do not comply with their obligations as regards payment of social security contributions, taxes and dues, according to the statutory provisions of the country where they are established;

- e. are an entity created to circumvent tax, social or other legal obligations (empty shell company), have ever created or are in the process of creation of such an entity;
- f. have been involved in mismanagement of public funds;
- g. were involved in the preparation of the prize documents and this entails a distortion of competition.

**4.2 Applicants shall deliver, when submitting their application, a declaration on their honour certifying that they are not in any of the above-mentioned situations.**

**4.3 Applicants shall be excluded from the grant award procedure:**

- a. if they fail to comply with the arrangements for the submission of their applications as set out in the call for proposals;
- b. if they are subject to a conflict of interests; a conflict of interests could arise in particular as a result of economic interests, political or national affinity, family, emotional life or any other shared interest;
- c. if they have misrepresented information required for participating in the contest or fail to submit such information;
- d. if they are members of the Scientific Committee of the Francesco della Valle Foundation.

## 5. Application

The proposal for the "Excellence in Neuroinflammation Award" must be submitted by filling out the online form at the following link: <https://francescodellavalle.foundation/en/excellence-in-neuroinflammation-award-2025/>. Applications are only accepted from the eligible author of an original research article. The online application must include the following information:

- a. Name and contact information for person submitting the nomination.
- b. Paper publication/acceptance details
- c. Short description of the applicant's contribution to the work (maximum 1,200 characters including spaces)
- d. PDF CV of the author
- e. PDF copy of the author's valid ID
- f. PDF of the original research article (published/accepted within the eligible award period)
- g. A no longer than 250 word-long statement about what, in author's opinion, makes the paper outstanding (i.e., the contribution that this paper has made or it will make to the field).

### 5.1 Application deadline

The deadline for applications is January 31, 2025 within 8:00 PM (UTC-GMT). Incomplete or late applications will be automatically rejected.

## 6. Award Criteria

The Scientific Committee members of Francesco della Valle Foundation will score candidate papers. They will consider innovation, significance to the research community, scientific impact and technical excellence. Each submission will be scored on a 0 (lowest) – 50 (highest) scale, based on each of the five 0 – 10 criteria below.

Criteria:

- a. scientific rigor: clear definition of the object, correspondence of the approach and method adopted to address the problem (score 0 – 10);
- b. innovativeness: discovery of unknown mechanisms/pathways (score 0 – 10);
- c. reproducibility: detailed method description (score 0 – 10);
- d. sustainability: ability to rely on existing resources without resorting to sponsorships external to the Institute of affiliation (score 0 – 10);
- e. translational nature: the potential use of the results in clinical practice (score 0 – 10).

The winning paper should substantiate a new and novel idea, and inspire fellow scholars in their research, as opposed to just grinding out yet another example of a well-known approach or result (even if the study was neatly conducted and reported). In other words, it is the "WOW" factor that we hope to see in the winning paper.

Based on the evaluation, the highest-ranked submission will be awarded the prize. In case of a tie, the selected publications will be awarded the same amount.

## 7. Management

Francesco della Valle Foundation will be responsible for the management of the evaluation process. The Foundation will inform the applicants about the decisions individually by March 30, 2025.

## 8. Award Presentation

The awardee will be invited to give an "Excellence in Neuroinflammation Award" special lecture, during the Excellence in Neuroinflammation Meeting to be held in Italy, Fall 2025. Beside the award, travel and accommodation will be charged to the Francesco della Valle Foundation.

## 9. Privacy and data processing

Personal data of the submitters will be processed by the Foundation exclusively for the purposes of managing procedures for the Award, in compliance with Legislative Decree 30 June 2003, n. 196 and subsequent amendments and EU Regulation n. 2016/679.
